ORDER:

In the G.O. 1st read above, guidelines were issued for issue of Minority Status to private Educational Institutions for making admissions and appointments etc. Further, vide G.O. 2nd read above, orders were issued that for determining the religious proof of the members of the Governing Body of the Educational Institutions, the same criteria as applicable in the case of the students shall be followed, i.e. production of SSC Certificate or any other equivalent record or TC from the schools in which the members of the Governing Body studied shall be the basis of the determining the religious status.

2) Subsequently, on the basis of the reports received from the School Education Department, certain modifications to sub-cause (2) of Clause (II) of G.O.Ms.No.1, Minorities Welfare (M&R) Department, dated 16-1-2004 have been issued vide G.O. 3rd read above, i.e., relaxing certain conditions in the production of T.C. for admission into Minority Colleges by the students.

3) Therefore, Government, after careful examination of the matter, hereby decide and accordingly order that the same relaxations / modifications issued in respect of the students seeking admissions in Minority Institutions vide G.O. 3rd read above, shall also apply to the members of the Governing Body of the Educational Institution for determining their religious status.
