The attention of all the Principals / Correspondents of Private Minority and Non-Minority Colleges in the State are informed that, the rule 3(ii)(c) of G.O.Ms.No.10 School Education Department dated 12.04.2017 is as follows:

"The Category B Seats shall be 20% of the total sanctioned intake of seats in D.EI.Ed., Programme in respect of Private Un-aided Minority Elementary Teacher Education Institutions, which shall be open to all the eligible candidates who satisfied the eligibility criteria for admission as mentioned in Rule 4 of these rules." and as per Rule 6 of the said Government Orders.

Therefore, all the Principals / Correspondents of Private Minority and Non-Minority Colleges in the State (D.EI.Ed., and D.P.S.E.) Colleges are requested take necessary action for filling up of the Category -B seats under Single Window -1 and Single Window -2, as per the schedule as detailed below:


